個人/聯名客戶開立證券買賣戶口需知 NOTE TO CLIENT (INDIVIDUAL/JOINT ACCOUNT) RELATING TO OPENING SECURITIES TRADING ACCOUNT

客戶開立現金證券買賣戶口,必須填妥及簽署以下文件:

For opening a cash securities trading account, client shall complete and sign the following documents:

- 1. 客戶資料表 個人/聯名賬戶 Client Information Form –Individual/Joint Account
- 2. 北向交易投資者識別碼模式客戶同意書 Client Consent on the Northbound Investor ID Model
- 3. W-8BEN 表格 W-8BEN Form
- 4. 客戶投資風險取向 Client Risk Profile

客戶並須提供下列文件:

In support thereof, client shall provide the documents listed below:

- 1. 身份證/護照副本
 - I.D./Passport Copy
- 2. 最近之住址證明 (例如:三個月內的電話費單,差餉單等等)
 - Latest proof of residential address (e.g. telephone bill, rate and rent etc. of the last three months)
- 3. 香港銀行戶□證明副本(例如:銀行咭,存摺,結單)
 - Bank proof copy (e.g. ATM card, passbook or bank statement)
- 4. 港澳通行證副本 (內地客戶)
 - Exit /Entry permit (Mainland resident)

如國內或海外客戶透過郵寄方式申請,客戶須填妥上述開戶文件並郵寄正本至本公司。 此外,申請人須選擇以下其中一項步驟核實身分證明:

If clients from Mainland China or overseas want to apply by mail, please mail the above-listed required documents to our company.

Additionally, clients must choose one of the procedures below to verify his/her true identity:

(一) 郵寄 HK\$10,000 連劃線個人支票,存款可作交易之用。Mail a crossed personal cheque of HK\$10,000. This deposit can be used for trading.

支票須符合以下條件 The cheque must satisfy the following requirements:

- A. 支票抬頭注明本公司的名稱 Cheque made payable to our company names;
- B. 必須是香港持牌銀行所發出的個人支票 Must be a personal cheque drawn on a licensed bank in Hong Kong;
- C. 支票所顯示的客戶全名及簽著必須與開戶表格相符 Must bear identical name and signature as shown on the account opening form。
- (二) 所有開戶文件須經在客戶居住當地的專業人仕(如:律師、執業會計師、持牌銀行經理、公證人)核證。

All account opening documents must be certified by a professional in the client's local area (e.g. lawyer, certified public accountant, branch manager of a bank, notary public).
